The main brasserie area may also be adapted for presentations theatre style, or seated lunch and dinner for up to 75 people.

TERMS & CONDITIONS

RESERVATIONS

The Brompton will hold tentative reservations for a maximum of 2 weeks. After this 2 week period, management reserves the right to cancel the booking and allocate it to another client if confirmation by deposit is not received.

CONFIRMATION DEPOSIT

Confirmation of a function booking must be made by payment of a deposit within 14 days of the initial enquiry. Deposits per room are charged as follows:

ADVICE OF FINAL NUMBERS

We require final numbers to be advised 7 days prior to the function date. Please be aware that this final number will be the number of guests for which the client will be charged. As the food has been purchased and prepared no refund is provided for “no-show” guests.

CATERING CONFIRMATION

Upon confirmation of final numbers, the food portion of your function requires full payment prior to the event.

SERVICE OF ALCOHOL

All functions that require the service of alcohol must be catered for by The Brompton.

MENU

Details of selected food and beverage options must be finalised at least 7 days prior to the function date. Any special dietary requirements such as vegetarian, vegan, gluten free or food allergies **must** be communicated upon initial arrangement of menu.

OCCUPATION OF FUNCTION AREAS

The client agrees to begin and end their function at the scheduled times.

Functions time frames are as follows:

MORNING	(Breakfast)	9:00am – 11:00am (earlier available by arrangement)
AFTERNOON	(Lunch)	12:00pm – 4:00pm
EVENING	(Dinner)	6:00pm – 11:30pm (MON – SAT) 6:00pm – 10:30pm (SUN)

MINORS

All children under the age of 18 must be supervised by an adult AT ALL TIMES. In accordance with Liquor Licensing Laws, all children under the age of 18 attending a function at The Brompton must vacate the premises by 12:00am.

COMPLIANCE

Clients must understand that it is their responsibility to conduct their function in an orderly manner. Management reserves the right to remove any persons whose behavior is deemed inappropriate, in accordance with laws regarding Responsible Service of Alcohol.

DECORATIONS

Table decorations and balloons are allowed, however nothing is to be nailed, screwed or adhered to any part of the wall or surface of the hotel. Foil table scatters and coloured napkins are not permitted as they stain table tops.

RESPONSIBILITY

The client accepts responsibility for damages, breakages or loss of hotel property or equipment. The client is financially responsible for any damage sustained to the property of the Brompton prior, during or after the function by the client, client's guests, or outside contractors of the client.

PAYMENT

All accounts are to be finalised prior to, or on completion of the function. We do not accept personal or company cheques. If you wish to pay by cheque, it must be done so 7 days prior to the function, allowing enough time for the cheque to clear. Cheques will not be accepted on the day / night of the function. Payment may be made by cash, EFTPOS or on a major credit card.

CANCELLATIONS

The deposit will only be refunded if the function is cancelled 30 days prior to the function. If the function is cancelled less than 30 days prior to the scheduled date, the deposit will be retained as compensation for loss of business.
